## **48/21 Minutes of the meeting held on Thursday, 8<sup>th</sup> July 2021**

The minutes of the meeting held on Thursday, 8<sup>th</sup> July 2021 were taken as read and APPROVED.

PROPOSED:- Councillor Mrs Kelly . SECONDED:- Councillor Mrs Glover.

Carried unanimously. .

## **49/21 Matters arising from those minutes.**

- a) 44/21 (c) Further discussions took place regarding photographic material for the Council’s web-site and it was AGREED that the forthcoming Lindal Village Gala would provide an opportunity for appropriate photographs. Councillor Fleming indicated that he could provide posters to advise residents accordingly.

- b) 44/21 (b) The Clerk confirmed that Barrow Borough Council was in the process of collating a list of sites where the planting of trees would be appropriate and that Lindal and Marton's interest was noted. It was suggested that Lindal village green might only require another two or three trees and it was hoped that the residents of both Lindal and Marton would come forward with suggestions as to which other areas might benefit by such tree planting.
- c) 32/21 (c) (May). Councillor Mrs Kelly reiterated her concerns over the apparently unauthorised developments at Tytup Smallholdings: the Clerk confirmed that nothing further had been heard, with the planning department still awaiting a planning application. It was AGREED that this was a matter of continuing concern and that further information should be sought for the next meeting.

### **50/20 Attendance of officer from Cumbria Constabulary**

There was no officer in attendance.

One incident was reported in the Parish for July, "domestic related harassment". (no further information)

Reference was made to the request for "SID" (Speed Indicator Device) to be placed in Marton because of concerns about speeding vehicles. This had not occurred because PCSO Louise Perry had been on holiday/detached duties for some time but it had now been arranged for SID to be installed w/c 9<sup>th</sup> August.

Further discussions took place regarding speeding problems within the Parish and it was AGREED that the Clerk would enquire as to the possibility of speed humps being made available, together with mph speed limits being painted on road surfaces.

### **51/21 Charging points, electric vehicles.**

Mr Mike Otto, Car Parks and Administrative Services Manager, Barrow Borough Council, was unable to attend as planned, due to his need to self-isolate because of Covid. Mr Otto would be invited to the September meeting.
