## **Minutes of the meeting held on Thursday, 3<sup>rd</sup> November, 2022 at 7.30 pm. in the Buccleuch Hall, Lindal.**

**Present:-** Councillors A Waite; Mrs S Glover; N Fleming.

**Apologies:-** Mrs S Kelly; Mrs C Stringer.

**Also present:** One member of the public was present.

**In attendance** Apologies from Borough Councillors Dan Edwards and Ben Shirley.

### **103/22 Urgent business. Items normally needing to be publicised but received too late for the agenda. (Section 100B (4) (b) Local Government Act 1972)**

None.

### **104/22 Disclosure of interests. Requests for dispensations.**

Councillor Waite declared an interest in item 8 (a), Planning Applications relating to the Parish, in that a family member was associated with the property in question.

### **105/22 Minutes of the meeting held on Thursday, 6<sup>th</sup> October 2022**

The minutes of the meeting held on Thursday, 6<sup>th</sup> October 2022, were taken as read and APPROVED.

PROPOSED:- Councillor Mrs Glover; SECONDED:- Councillor Fleming.  
Carried unanimously.

### **106/22 Matters arising from those minutes.**

None.

### **107/22 Attendance of officer from Cumbria Constabulary**

There was no officer in attendance but details had been submitted regarding recent problems, viz:-

- 1 report of vehicle causing an obstruction. Vehicle removed before police attended.
- 1 report of a two-vehicle road traffic accident. No further details.

### **108/22 Overgrowing trees, hedgerows etc**

Councillor Fleming commented on complaints he had received from local residents regarding overgrown and overhanging trees and bushes in some parts of Lindal. It was AGREED that the Clerk would contact the Borough Council regarding Lindal village green and the County Council regarding Pit Lane with a request that an assessment be made of these areas and remedial action be taken where necessary.

### **109/12 Planning applications relating to the Parish**

a) *B21/2022/ Kinnago, Lindal Moor Road, Lindal. General rebuild.*

Having previously declared an interest, Councillor Waite took no part in the discussion. The Council was then not quorate and, as a consequence, no consideration could be given to the application.

b) *B21/2022/0731. Green View, Lindal. Detached building to form an art studio.*

It was PROPOSED by Councillor Fleming and SECONDED by Councillor Mrs Glover that the Council confirm that it had no objections to the application. Carried unanimously.

### **110/22 Planning application outside the Parish.**

*5/22/9007, (County Council matter, Minerals and/or Waste Development) Tony Brown Aggregates, Pennington Lane, Lindal. Request to amend condition 9 of approved application for extension to stockpile areas i.e., extend time-frame for building of concealment bunds to 31-10-24.*

It was PROPOSED by Councillor Waite and SECONDED by Councillor Fleming that the Council confirm that it had no objections. Carried unanimously.

### **111/22 Correspondence.**

- a) Planning applications relating to the whole of the Borough. The Clerk confirmed that the latest on-line list from Barrow Borough Council had been received and forwarded to Councillors. NOTED.

### **112/22 Finance**

- a) Account balances:- *Current* - £50: *Festivals* - £673.56 - *Reserve* - £5197.38
- b) Payments recently made, for formal authorisation:-
- 1) Great North Air Ambulance. Donation. £150.
  - 2) Imperative Training Ltd. Defibrillator. £1596.  
(This latter amount includes VAT of £266 which is recoverable from HMRC)
  - 3) British Legion, Remembrance Day wreaths. £34.
- c) The sum of £1500 had been received from the Keswick-to-Barrow Walk Committee for the purchase of a defibrillator to be sited in Marton. Consideration was given to the most appropriate site for the machine and the ex-BT telephone kiosk, currently used as a mini library, was suggested as suitable. It was AGREED that an article be prepared for inclusion in “Aspects” to advise residents of the proposal with an indication that training would be provided in due course.

It was then PROPOSED by Councillor Mrs Glover and SECONDED by Councillor Fleming that the payments shown in item (b) be duly formally approved. Carried unanimously.

### **113/22 Any Other Business.**

- a) Remembrance Sunday would be on November 13<sup>th</sup>, Councillor Mrs Glover being in attendance at Marton War Memorial for the 2.00 pm ceremony and Councillor Fleming and the Clerk attending Lindal War Memorial for the 10.15 ceremony.
- b) The Chairman drew attention to the flooding recently experienced in parts of Lindal and Marton. The Clerk confirmed that he would approach the lengthman, Archie Workman, to see whether he could look at some of the blocked drains. He would also raise the subject of leaf-clearance etc with the Borough and County Councils.
- c) Councillor Mrs Glover referred to the coming festive season and the plans for the annual Christmas Fair in the Buccleuch Hall and also the Christmas Party for older residents. It was confirmed that the Christmas Tree on the village green would be erected in time for the Fair and that the requirement for the usual funding in connection with the Party would be an agenda item for the December meeting.
- d) *From the floor*, further information was received about the activities taking place on the site of Tytup Smallholdings. It was suggested that deliveries of waste materials were still being delivered to the site, contrary to assurances previously made by the site owner, and it was also alleged that the pigs on the site were subject to inhumane treatment. The Clerk undertook to raise the matter with the appropriate authorities.

### **114/22 Date and Time of next meeting**

The date and time of the next meeting was AGREED as Thursday, 1<sup>st</sup> December, 2022, at 7.30 pm in the Buccleuch Hall, Lindal.
